APPROVING RESOLUTION NO. 2017-203 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "ADOPTING THE SUPPLEMENTAL INVESTMENT PLAN NO. 2017-06 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2017-203 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Binalonan, Pangasinan has formulated the municipality's Supplemental Investment Plan No. 2017-06 amounting to P3,165,228.13. This was endorsed thru MDC Resolution No. 6 dated September 26, 2017 to the Sangguniang Bayan and was subsequently approved by their Sangguniang Bayan through Resolution No. 2017-203 dated September 28, 2017;

WHEREAS, the Supplemental Annual Investment Plan No. 6 of Binalonan, Pangasinan covers fund augmentation for Maintenance and Other Operating Expenses of some offices of the municipality, Capital Outlay expenditures and implementation of Solid Waste Management Program of the LGU;
