PROVINCIAL RESOLUTION NO. 581-2020

INVITING POLICE COLONEL REDRICO A. MARANAN, PROVINCIAL DIRECTOR, TO APPEAR BEFORE THE SANGGUNIANG PANLALAWIGAN DURING ITS QUESTION HOUR ON JULY 6, 2020 REGULAR SESSION TO APPRISE AND UPDATE THE AUGUST BODY ON THE PEACE AND ORDER SITUATION OF THE PROVINCE AND THE NEW PLANS AND PROGRAMS OF THE PRESENT ADMINISTRATION OF THE PANGASINAN POLICE PROVINCIAL OFFICE ESPECIALLY ON ITS CAMPAIGN AGAINST ILLEGAL DRUGS, IMPLEMENTATION OF COVID-19 MEASURES AND OTHER PERTINENT MATTERS OF THE PROVINCE

WHEREAS, the Philippine National Police is mandated to enforce law to prevent and control crimes, maintain peace and order and ensure public safety and security with the active support of the community;


