PROVINCIAL RESOLUTION NO. 583-2020

APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 4 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2020

WHEREAS, presented for consideration is the Supplemental Investment Program No. 4 of the Province of Pangasinan as endorsed by the Provincial Development Council through PDC EXECOM Resolution No. 07-20;

WHEREAS, Supplemental Investment Program No. 4 contains other priority programs, projects and activities that are not included in the approved 2020 Provincial Annual Investment Program of Pangasinan;

WHEREAS, the Supplemental Investment Program No. 4 shall cover the granting of Hazard Pay to the employees of the Provincial Government offices and hospitals pursuant to Administrative Order No. 26 dated March 23, 2020 and Budget Circular No. 2020-1 dated March 24, 2020 from March 17 to May 15, 2020; implementation for the Maintenance and Other Operating Expenses of some offices and hospitals; implementation of the Economic Rehabilitation and Recovery Program (Abig Pangasinan) of the Province; and development projects, among others;

WHEREAS, the **P81,422,974.00** total investment requirement of Supplemental Investment Program No. 4 is fully supported by Supplemental Budget No. 4 which shall be sourced from the reversion of current appropriation – savings on Personal Services and Other Special Purpose Appropriations and unappropriated surplus;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;


WHEREAS, after careful study of the said Program, this august Body finds it to be in order;
