APPROVING RESOLUTION NO. 179, S-2021 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 3 WITH THE CY 2021 SUPPLEMENTAL ANNUAL INVESTMENT PLAN NUMBER 2 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its SB Resolution No. 179, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Development Council of Asingan, Pangasinan has reprogrammed some programs of the previous years to fund COVID 19 related programs, projects and activities in the Amount of P2,500,000.00 which is embodied in the LGUs Supplemental Investment Plan No. 02 which was endorsed through MDC Resolution No. 3, S-2021 dated May 26, 2021;

**WHEREAS**, said Supplemental AIP covers the LGU's priority programs and projects and payment of loans;

WHEREAS, the projects, food assistance and other relief goods for affected households and procurement of hospital equipment and supplies are in accordance with the Department of Budget and Management Local Budget Circular No. 124 dated March 26, 2020 (Policy Guidelines on the provision of funds by Local Government Units for Programs, Projects and Activities to address the Corona Virus Diseases 2019 Situation) and DILG-DBM-JCM No. 01 dated March 27, 2020 (Additional Guidelines on the Utilization of the Twenty Percent [20%] of the Annual Internal Revenue Allotment for Development Projects in view of the Corona Virus Diseases 2019 Situation);
