RESOLUTION NO. 587-2020

DECLARING ORDINANCE NO. 2020-12 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “AN ORDINANCE LOCALIZING THE DEPARTMENT OF TRANSPORTATION (DOTR) GUIDELINES ON TRANSPORTATION APPLICABLE TO THE CITY OF ALAMINOS, PANGASINAN FOR THE DURATION OF COMMUNITY QUARANTINE AND ANY EXTENSION THEREOF” AS WITHIN THE POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2020-12 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 458 (a) (5) (v) of RA 7160; and the Omnibus Public Transport Protocols/Guidelines set by the Department of Transportation and the Inter-Agency Task Force for the Management of Emerging Infectious Diseases;

WHEREAS, subject ordinance shall take effect after the Sangguniang Panlungsod has complied with the requirements of posting and publication pursuant to Sections 59 and 511 of RA 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –


