ALEGRIA ALMAJANO, PROVINCIAL FEDERATION PRESIDENT OF BARANGAY HEALTH WORKERS FOR ANOTHER QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN ON THE NEXT REGULAR (PHYSICAL) SESSION TO FURTHER APPRISE THE BODY ON THE MECHANICS OF GRANTING SPECIAL RISK ALLOWANCE (SRA) TO HEALTH WORKERS IN THE PROVINCE OF PANGASINAN**

**WHEREAS**, relative thereto, a Question Hour was scheduled and conducted on June 28, 2021 with the attendance of representatives from the Department of Health-Regional and Pangasinan Offices, and the personal appearances of Dr. Anna Ma. Teresa S. de Guzman, Provincial Health Office, and Mrs. Alegria Almajano, Provincial Federation President of Barangay Health Workers;

**WHEREAS**, among the main questions that were asked are the basis for the computation of the SRA, the varying amounts of SRA being given to Barangay Health Workers (BHW) in some areas of the Province, and the verification and approval of the masterlist of BHW;
