APPROVING RESOLUTION NO. 2020-81 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED “CONFIRMING/APPROVING IN TOTO THE PROPOSED CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 04 (SAIP NO. 04) OF THE CITY OF ALAMINOS, PANGASINAN AMOUNTING TO TWO HUNDRED THOUSAND PESOS (P200,000.00)”

WHEREAS, the Sangguniang Panlungsod of Alminos, Pangasinan submitted its Resolution No. 2020-81 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Alaminos City, Pangasinan had identified items in their Supplemental Investment Program No. 4 for CY 2020. This was endorsed to the Sangguniang Panlungsod for approval on April 27, 2020 by the City Development Council thru CDC Executive Committee Resolution No. 03, S-2020 and was favorably acted upon by the Sangguniang Panlungsod on May 5, 2020 thru SP Resolution No. 2020-81;

WHEREAS, the Supplemental Investment Program No. 4 of the city covers project in response to the crisis brought about by the COVID-19 pandemic;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P200,000.00 to be sourced from the Energy Regulation (ER) 1-94 funds by the Department of Energy (DOE) as prescribed under DOE Department Circular No. 2020-04-008;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
