APPROVING RESOLUTION NO. 2020-15 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED “ADOPTING THE REVISED ANNUAL INVESTMENT PROGRAM CY 2020 OF THE MUNICIPALITY OF BOLINAO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Resolution No. 2020-15 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Bolinao, Pangasinan endorsed to the Sangguniang for approval the Revised Annual Investment Program CY 2020 on March 28, 2020 thru MDC Resolution No. 1-B, S-2020. This was favorably acted upon by the Sangguniang Bayan on March 31, 2020 thru SB Resolution No. 2020-15;

WHEREAS, the 2020 AIP of the Municipality of Bolinao was revised to integrate the Revised Local Disaster Risk Reduction and Management Fund Investment Plan (LDRRMFIP) prepared and endorsed by the LDRRM Council thru MDRRMC Resolution No. 03, S-2020. The LDRRMFIP includes programs, projects and activities (PPAs) in response to the crisis due to COVID-19 pandemic, which were proposed to be funded by the municipality's unexpended balances of their LDRRMF CYs 2015, 2016, 2017, 2018 and 2019 Trust Fund in the amount of P13,488,779.62. This is in accordance with Item 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of the Interior and Local Government;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
