DECLARING MUNICIPAL ORDINANCE NO. 2018-009 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING A LAND COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. T-60578 WITH AN AREA OF FOUR THOUSAND FOUR HUNDRED NINETY EIGHT (4,498) SQUARE METERS LOCATED IN BARANGAY LEGASPI, TAYUG, PANGASINAN FROM AGRICULTURAL LAND USE INTO COMMERCIAL LAND USE" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Tayug, Pangasinan submitted its Municipal Ordinance No. 2018-009 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Officer and the Housing and Land Use Regulatory Board have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 20 of RA 7160;

WHEREAS, the Municipality of Tayug has an approved Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2016-2025;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2018-009 of the Sangguniang Bayan of **Tayug**, Pangasinan, entitled "An Ordinance reclassifying a land covered by Transfer Certificate of Title (TCT) No. T-60578 with an area of Four Thousand Four Hundred Ninety Eight (4,498) square meters located in Barangay Legaspi, Tayug, Pangasinan from agricultural land use into commercial land use" as within the conferred powers of the Sangguniang Bayan to enact;
