APPROVING RESOLUTION NO. 073-2021 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL NO. 2 OF THE ANNUAL INVESTMENT PROGRAM, CALENDAR YEAR 2021 OF THE MUNICIPALITY OF AGNO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its SB Resolution No. 073-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

WHEREAS, Local Development Council of Agno, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021 with a total investment requirement of P5,522,459.52 which was endorsed to the Sangguniang Bayan for approval on June 1, 2021 through MDC Executive Committee Resolution No. 02-2021;

WHEREAS, said Supplemental AIP covers the fund augmentation for the Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices;

WHEREAS, funding for the full implementation of this Supplemental Investment Program is embodied in Supplemental Budget No. 2 for CY 2021 of the municipality which was approved and enacted by the Sangguniang Bayan of Agno on June 7, 2021 through Appropriation Ordinance No. 2021-02;
