APPROVING RESOLUTION NO. 04-20-19 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED “ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM (AIP), SERIES OF 2020 OF THE LGU OF MABINI, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Resolution No. 04-20-19 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Mabini, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on March 30, 2020 by the Municipal Development Council thru Executive Committee Resolution No. 01, S-2020 and was favorably acted upon by the Sangguniang Bayan on April 6, 2020 thru SB Resolution No. 04-20-19;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers fund augmentation for the personal services and maintenance and other operating expenses of municipal offices and implementation of development projects, gender and development activities, local risk reduction programs and projects/activities to address the crisis brought about by the COVID-19 pandemic;
