APPROVING RESOLUTION NO. 25, S-2021 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) WITH A TOTAL AMOUNT OF P2,777,109,296.85 FOR CY 2021 OF THE MUNICIPALITY OF BUGALLON, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its SB Resolution No. 25-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the 2021 AIP of the Municipality of Bugallon was revised to integrate the Revised Local Risk Reduction and Management Fund Investment Plan (LDRRMFIP) which was prepared and endorsed by the LDRRM Council through MDRMMC Resolution on April 28, 2021. The LDRRMFIP includes the Relief Goods for Door-to-Door Community Food Assistance Program proposed to be funded from the municipality's unexpended balance of their LDRRMF CYs 2018, 2019 and 2020 (Trust Fund) in the amount of P4,678,181.84. This is in accordance with Item 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-12 dated March 25, 2013 of the Department of Interior and Local Government;


