THIS IS TO CERTIFY that at the special session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on July 24, 1989 at Lingayen, Pangasinan, the following resolution was approved:

PROVINCIAL ORDINANCE NO. 5

AMENDING PROVINCIAL ORDINANCE NO. 4 ENTITLED "PROVINCIAL ORDINANCE CREATING SITIO NIBALIW WEST PROPER OF BARANGAY NIBALIW WEST; SITIO NIBALIW COMPOUND OF BARANGAY NIBALIW WEST; AND SITIO COLISAO OF BARANGAY BINDAY, ALL OF SAN FABIAN, PANGASINAN, INTO THREE (3) SEPARATE, DISTINCT AND INDEPENDENT BARANGAYS TO BE NAMED "BARANGAY NIBALIW WEST PROPER", BARANGAY NIBALIW WEST COMPOUND" AND "BARANGAY COLISAO" RESPECTIVELY, OF SAN FABIAN, PANGASINAN.

WHEREAS, this Body is in receipt of a copy of Resolution No. 02-59-S-89 of the Sangguniang Bayan of San Fabian, Pangasinan, requesting Sangguniang Panlalawigan to favorably act upon the petition of residents of the said sitios of said barangays for the creation of a new and independent barangays out of the said sitios to be named "Barangay Nibaliw West Proper, "Barangay Nibaliw West Compound" and "Barangay Colisao, San Fabian, Pangasinan, pursuant to Section 83 of the Local Government Code otherwise known as Republic Act No. 337;

WHEREAS, pursuant to the pertinent provisions of the New Local Government Code, in the creation of new barangay, all the essential requirements therein are satisfactorily met;

WHEREAS, the residents and leaders therein are of the firm belief that the creation would hasten social, economic and political developments in the area and foster delivery of basic services;

NOW, THEREFORE, in view of the foregoing, on motion of Board Member Dionisio C. Antiniw, duly seconded by Board Members Roberto N. Ferrer, Roberto Q. Sison, and Romualdo G. de Leon, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to create as it is hereby created Sitio Nibaliw West Proper, Nibaliw West Compound, and Sitio Colisao of Barangay Binday, San Fabian, Pangasinan, into three (3) new, separate, distinct and independent barangays to be named "BARANGAY NIBALIW WEST PROPER", BARANGAY NIBALIW WEST COMPOUND" AND "BARANGAY COLISAO", RESPECTIVELY, of San Fabian, Pangasinan, with the following boundaries, to wit:

NIBALIW WEST PROPER

- On the North - - - - - Sobol River
- On the South - - - - - Sanitas Elementary School
- On the East - - - - - Ilog na Bahley (Small River)
- On the West - - - - - Lingayen Gulf

NIBALIW WEST COMPOUND

- On the North - - - - - By a concrete Wall Ten feet high
- On the South - - - - - By a concrete Wall Ten feet high
- On the East - - - - - By a concrete Wall Ten feet high
- On the West - - - - - Lingayen Gulf

C O L I S A O

- On the North - - - - - Bindow Dam
- On the South - - - - - Boundary between Barangay Bindow and Barangay Ambalangan dalin clearly delineated by a Cadastral Monument
- On the East - - - - - Top of Ridge of Hill Separating Bindow Proper and Sitios Colisao
- On the West - - - - - Bued River


RESOLVED, FURTHER, to request the COMELEC to schedule the holding of a plebiscite in these new barangays from approval of this ordinance and for the COMELEC to duly inform this Body of the holding of such plebiscite for its information and guidance;

RESOLVED, FURTHERMORE, that the Provincial Assessor in coordination with other agencies, determine the official boundaries of these newly created barangays for the official record and for the information of of concerned;

RESOLVED, FINALLY, that copies of this resolution be furnished the Provincial Assessor, Provincial Treasurer, Provincial Auditor, Provincial Engineer, the DLG, Bureau of Lands, PC-INP, COMELEC and DECS for their information and guidance.
