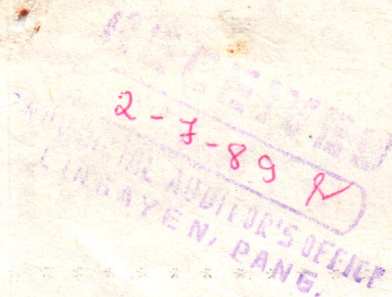

TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on December 5, 1988, at Lingayen, Pangasinan, the following Ordinance was approved:

PROVINCIAL ORDINANCE NO. 6

AN ORDINANCE CREATING THE TWELVE (12) SITIOS OF BARANGAY FIANZA INTO INDEPENDENT BARANGAY TO BE NAMED "BARANGAY KULANGEW", SAN NICOLAS, PANGASINAN

WHEREAS, this Body is in receipt of Resolution No. 9-c, series of 1988 of the Sangguniang Bayan of San Nicolas, Pangasinan requesting the Sangguniang Panlalawigan to favorably act upon the petition of 12 sitios of Barangay Fianza for the creation of a new and independent barangay out of the said sitios to be named "Barangay Kulangew", pursuant to Section 83 of the Local Government Code otherwise known as Republic Act No. 337;

WHEREAS, pursuant to the pertinent provisions of the New Local Government Code, in the creation of new barangays, all the essential requirements therein are satisfactorily met;

WHEREAS, the residents and leaders therein are of the firm belief that the creation would hasten and exercise social, economic and political development in the area and foster faster delivery of basic services;

NOW, THEREFORE, in view of the foregoing, on motion of Board Member Dionisio C. Antiniw, duly seconded by Board Member Francisco F. Baraan III, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to create, as it is hereby created the 12 sitios of Barangay Fianza into one independent barangay to be named "Barangay Kulangew", San Nicolas, Pangasinan;

RESOLVED, FURTHER, to request the Comelec to schedule the holding of a plebiscite ~~in this~~ new barangay within 45 days from approval of this Ordinance and for the Comelec to duly inform this Body of the holding of such plebiscite for its information and guidance;

RESOLVED, FURTHERMORE, that the Provincial Assessor in coordination with other agencies, determine the official boundaries of this newly created barangay for the official record and for the information of all concerned;

RESOLVED, FINALLY, that copies of this ordinance be furnished the Provincial Assessor, Provincial Treasurer, Provincial Auditor, Provincial Engineer, the DLG, DPWH, Bureau of Lands, PC-INP, COMELEC and DECS for their information and guidance.
