PROVINCIAL RESOLUTION NO. 6-2019

WHEREAS, illegal structures on many sections of the road right-of-way of national roads create encroachments and/or obstructions constricting the road and causing traffic congestions, and pose grave danger to the traveling public;

WHEREAS, totally stopping encroachments or illegal structures on the road right-of-way of the national roads is an enormous responsibility in view of the manifold problems that may ensue in the pursuit thereof;

WHEREAS, a concerted effort among government agencies and local government units to protect and preserve the road right-of-way of the national roads in Region 1 must be realized;

WHEREAS, to address all the issues and concerns pertaining to Staying Safe and Moving Fast along the Manila North Road, there is a need to strengthen a system of coordination and cooperation among the citizenry, local chief executives, concerned national government agencies and the integrated law enforcement and public safety agencies to ensure safe transportation environment and to minimize, if not to prevent, vehicular accidents;

WHEREAS, to this end, a Memorandum of Agreement shall be entered into and signed between and among the Province of Pangasinan, represented by Governor Amado I. Espino III, Regional Law Enforcement Coordinating Committee I and Philippine National Police-Regional Office 1, Regional Law Enforcement Coordinating Committee I Sub-Committee on Traffic Management and Law Enforcement, the Regional Offices of the Land Transportation Office, Department of the Interior and Local Government, Department of Public Works and Highways, Department of Environment and Natural Resources, Philippine Ports Authority and Department of Transportation, Land Transportation Franchising and Regulatory Board, Technical Education and Skills Development Authority, Philippine Information Agency, Department of Justice, and the Local Government of Ilocos Norte, Ilocos Sur, and La Union;

WHEREFORE, in view of the foregoing, on motion of SP Member Noel C. Bince, duly seconded, it was -

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Amado I. Espino III, to enter into and sign a Memorandum of Agreement between and among the Province of Pangasinan and the Regional Law Enforcement Coordinating Committee I and Philippine National Police-Regional Office 1, Regional Law Enforcement Coordinating Committee I Sub-Committee on Traffic Management and Law Enforcement, the Regional Offices of the Land Transportation Office, Department of the Interior and Local Government, Department of Public Works and Highways, Department of Environment and Natural Resources, Philippine Ports Authority and Department of Transportation, Land Transportation Franchising and Regulatory Board, Technical Education and Skills Development Authority, Philippine Information Agency, Department of Justice, and the Local Government of Ilocos Norte, Ilocos Sur, and La Union;
