APPROVING RESOLUTION NO. 099-2019 OF THE SANGGUNIANG BAYAN OF AGNO, PANGASINAN, ENTITLED "APPROVING SUPPLEMENTAL NO. 2 OF THE ANNUAL INVESTMENT PROGRAM, CALENDAR YEAR 2019 OF THE MUNICIPALITY OF AGNO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Agno, Pangasinan submitted its Resolution No. 099-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Agno, Pangasinan had identified items in their Supplemental Investment Program for CY 2019 with a total investment requirement of P8,168,000.00. This was endorsed to the Sangguniang Bayan for approval on September 16, 2019 thru MDC Executive Committee Resolution No. 02-2019 and was favorably acted upon by the Sangguniang Bayan on September 30, 2019 thru SB Resolution No. 074-2019;

WHEREAS, the Supplemental Investment Program No. 2 for CY 2019 of the municipality covers the Capital Outlay Projects and fund augmentation for the Maintenance and Other Operating Expenses of the various municipal offices;
