No. 11032 "An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services"

**WHEREAS,** subject ordinance shall take effect after the requirements of public hearing, posting and publication pursuant to Sections 187, 188, and 59 of RA 7160 are complied with;
