**DECLARING MUNICIPAL ORDINANCE NO. 02-04192021 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE ON COLLECTION OF CORRESPONDING BARANGAY CLEARANCE FEE IN THE APPLICATION FOR ANY BUSINESS-RELATED TRANSACTIONS IN THE MUNICIPALITY OF POZORRUBIO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Municipal Ordinance No. 02-04192021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer has conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (3) (i) (iii) of RA 7160; Section 11 (f) of R.A. No. 11032 “An Act Promoting Ease of Doing Business and Efficient Delivery of Government Services”

**WHEREAS**, subject ordinance shall take effect after the requirements of public hearing, posting and publication pursuant to Sections 187, 188, and 59 of RA 7160 are complied with;
