APPROVING RESOLUTION NO. 68-05042020 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “APPROVING THE 2ND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN FOR CY 2020 REALIGNING THE CURRENT 2020 LOCAL DISASTER RISK REDUCTION MANAGEMENT FUND (LDRRMF-70% COMPONENT) OF THE LGU TO AUGMENT THE FUNDING REQUIREMENT OF ERADICATING/SUPPRESSING THE CORONAVIRUS DISEASE (COVID-19) AND TO PROVIDE RELIEF ASSISTANCE TO AFFECTED POPULATION, THE GRANT OF SPECIAL RISK ALLOWANCE TO PUBLIC HEALTH WORKERS, HAZARD PAY AND IMPLEMENTATION OF SALARY STANDARDIZATION LAW V (FIRST TRANCHE) TO BE FUNDED BY THE REVERSION OF APPROPRIATIONS AND SURPLUS/SAVINGS FROM PREVIOUS YEAR OF LGU-POZORRUBIO, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 68-05042020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council thru MDC Resolution No. 02, S-2020 has endorsed the municipality’s Second Supplemental Annual Investment Program to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan thru Resolution No. 68-05042020 dated May 4, 2020;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 68-05042020 of the Sangguniang Bayan of Pozorrubio, Pangasinan, entitled “Approving the 2nd Supplemental Annual Investment Program of the Municipality of Pozorrubio, Pangasinan for CY 2020 realigning the current 2020 Local Disaster Risk Reduction Management Fund (LDRRMF-70% Component) of the LGU to augment the funding requirement of eradicating/suppressing the Coronavirus Disease (COVID-19) and to provide relief assistance to affected population, the grant of Special Risk Allowance to Public Health Workers, Hazard Pay and Implementation of Salary Standardization Law V (First Tranche) to be funded by the reversion of appropriations and surplus/savings from previous year of LGU-Pozorrubio, Pangasinan”;
