PROVINCIAL RESOLUTION NO. 605-2021

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III TO SIGN A DEED OF DONATION AND RECEIVE ONE (1) UNIT OF LAND AMBULANCE FROM THE PITMASTER FOUNDATION, INC.

WHEREAS, one of the primordial concerns of the provincial government of Pangasinan is to address health issues and provide medical service needs of the people;

WHEREAS, the Pitmaster Foundation, Inc., a non-stock and non-profit corporation which supports national and local government's health programs, has been donating ambulances for the upgrading of medical and health care facilities;

WHEREAS, the Province of Pangasinan will be the recipient of one (1) unit of land ambulance (with medical supplies and accessories) from the Pitmaster Foundation, Inc. in the form of a donation and hereby expresses its willingness to accept the same;

WHEREAS, this ambulance can be used primarily by the Province to cater and respond immediately to the health necessities of the people especially in times of emergencies;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to sign the Deed of Donation and accept the ambulance from the Pitmaster Foundation, Inc. to further augment the need for medical service vehicles of the Province;


