**APPROVING RESOLUTION NO. 19(A)-033 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 4 FOR CALENDAR YEAR 2019 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN”**

**WHEREAS**, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 19(A)-033 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council-Executive Committee of San Carlos City, Pangasinan prepared the City’s Supplemental Investment Program No. 4 for CY 2019. This was endorsed by the Council through CDC Resolution No. 04-19 (Series of 2019) dated August 22, 2019 to the Sangguniang Panlungsod for approval. The Sangguniang Panlungsod approved said endorsement thru SP Resolution No. 19(A)-033 dated August 28, 2019;

**WHEREAS**, the Supplemental Investment Program which has a total investment requirement of P47,901,161.14 covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay and other development undertakings of the city;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
