**APPROVING RESOLUTION NO. 40, S-2020 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED “APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) OF THE MUNICIPALITY OF STO. TOMAS, PANGASINAN FOR CALENDAR YEAR 2020”**

**WHEREAS**, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 40, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sto. Tomas, Pangasinan has formulated, adopted and endorsed the municipality’s Supplemental Annual Investment Program (SIP-01-22-2020) through MDC Resolution No. 01-S-2020 dated March 4, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on March 20, 2020 through Resolution No. 40, S-2020. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

**WHEREAS**, the Supplemental Annual Investment Program (SIP-01-22-2020) has an investment requirement amounting to P1,163,432.10 which covers programs/projects/activities to address emergency response measures to COVID-19;

**WHEREAS**, on March 20, 2020, the Sangguniang Bayan enacted Supplemental Budget No. 1, S-2020 through Appropriation Ordinance No. 01, S-2020 to support the implementation of the Supplemental Annual Investment Program (SIP-01-22-2020) of the municipality;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
