## RESOLUTION NO. 608-2021

DECLARING ORDINANCE NO. 155, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE HONORING AND GRANTING OF CASH INCENTIVES TO BASISTA ELDERLIES AGING 80 – 100 AND ABOVE AND PROVIDING FUNDS THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Municipal Ordinance No. 155, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (b) (2) and 447 (a) (5) (xvi) of RA 7160; Republic Act No. 9994, otherwise known as "Expanded Senior Citizens Act of 2010"; and Republic Act 10868 otherwise known as "An Act Honoring and Granting Additional Benefits and Privileges to Filipino Centenarians, and for Other Purposes";

**WHEREAS,** subject ordinance shall take effect after the requirement of posting pursuant to Section 59 of RA 7160 is complied with;
