APPROVING RESOLUTION NO. 46, S-2020 OF THE SANGGUNIANG BAYAN OF STO. TOMAS, PANGASINAN, ENTITLED “APPROVING/ADOPTING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2 (SIP#02 SS-2020) OF THE MUNICIPALITY OF STO. TOMAS, PANGASINAN FOR CALENDAR YEAR 2020”

WHEREAS, the Sangguniang Bayan of Sto. Tomas, Pangasinan submitted its Resolution No. 46, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sto. Tomas, Pangasinan has formulated, adopted and endorsed the municipality’s Supplemental Investment Program No. 2 through MDC Resolution No. 02-SS-2020 dated April 8, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on April 21, 2020 through Resolution No. 46, S-2020. This is in pursuance to Sections 106, 109, and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 2 with an investment requirement amounting to P5,595,235.00 covers programs/projects/activities to address emergency response measures to COVID-19 pandemic. This will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA No. 11469 (The Bayanihan To Heal As One Act);
