APPROVING RESOLUTION 29. S-2021 NO. **OF** THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FY 2021 OF THE MUNICIPALITY OF BUGALLON, PROVINCE OF PANGASINAN INVOLVING THE AMOUNT OF FOURTEEN MILLION EIGHT HUNDRED EIGHTY-TWO THOUSAND SIX HUNDRED THIRTY-FIVE PESOS AND **FORTY-NINE CENTAVOS (P14,882,635.49)**"

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its SB Resolution No. 29, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

WHEREAS, the Local Development Council of Bugallon, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY which was endorsed to the Sangguniang Bayan for approval on June 1, 2021 through MDC Resolution No. 01-2021;

WHEREAS, said Supplemental AIP covers the fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, programs and projects to address the impacts of COVID-19 and implementation of development projects of the municipality;

Funding support for the full implementation of the same is embodied in Supplemental Budget No. 1 for FY 2021 of the municipality which was approved and enacted by the Sangguniang Bayan of Bugallon on June 1, 2021 through Appropriation Ordinance No. 2021-01;
