THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on July 11, 1997 at Lingayen, Pangasinan, the following resolution was approved:

**PROVINCIAL ORDINANCE NO. 61-97**

AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 45-94 GRANTING A NON-EXCLUSIVE FRANCHISE TO METRO DAGUPAN-FIRST ILOCANDIA CABLE TELEVISION, INC., TO MAINTAIN AND OPERATE A CABLE TV SYSTEM IN THE MUNICIPALITY OF CALASIAO

Be it enacted by the Sangguniang Panlalawigan in Session called for the purpose.

Section 1. Provincial Ordinance No. 45-94, passed and approved on December 9, 1994, grants a non-exclusive Provincial Franchise to METRO DAGUPAN-FIRST ILOCANDIA CABLE TELEVISION, INC., to maintain and operate a cable TV system in the Municipality of Calasiao.

Section 2. By virtue of the adoption of a tradename by the Franchisee-Grantee, the title of Provincial Ordinance No. 45 is hereby amended to read as follows:

"AN ORDINANCE GRANTING A NON-EXCLUSIVE FRANCHISE TO FIRST ILOCANDIA CABLE TV, INC., DOING BUSINESS UNDER THE TRADENAME "SKYCABLE", TO INSTALL, OPERATE AND MAINTAIN A CABLE TELEVISION SYSTEM IN THE MUNICIPALITY OF CALASIAO, PROVINCE OF PANGASINAN AND FOR OTHER PURPOSES."

Section 3. Relevant to the amendment of the title of the aforesaid Ordinance, all portions of Provincial Ordinance No. 45-94, where the grantee's or franchisee's business name is mentioned, the words "doing business under the tradename "SKYCABLE", shall be added.

Section 4. This Ordinance shall take effect upon its approval.
