WHEREAS, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Resolution No. 20-50-A to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Disaster Risk Reduction and Management Council in its Resolution No. 1, S-2020 dated March 9, 2020, has endorsed to the Sangguniang Bayan for approval the revised MDRRM Plan to include programs/projects in response to COVID 19 pandemic which will be funded by Supplemental Budget No. 1 and CY 2015-2019 QRF under trust fund;

WHEREAS, the Local Development Council has revised the CY 2020 Annual Investment Program to include LDRRM programs/projects in response to COVID 19 pandemic which will be funded from the unexpended Quick Response Fund for the years 2015-2019 (P7,139,616.57) and Supplemental Budget No. 1 (P1,050,808.96). This was endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2020-01 dated March 13, 2020;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
