RESOLUTION NO. 613-2021

APPROVING RESOLUTION NO. 64, S-2021 OF THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF CALASIAO, FOR THE YEAR 2021"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its SB Resolution No. 073-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SP Resolution and found out that the Municipal Development Council of Calasiao, Pangasinan prepared the municipality's Supplemental Annual Investment Program for CY 2021. This was endorsed by the Council through MDC Resolution No. 1, Series of 2021 dated April 28, 2021 to the Sangguniang Bayan for approval;

WHEREAS, said Supplemental AIP which has a total investment requirement of P34,916,667.49 covers the augmentation funds for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of the LGU, to include payment for the Performance-Based Bonus (PBB) of qualified personnel, and implementation of COVID-19 related PPAs and other development projects of the LGU;

WHEREAS, funding for the full implementation of this Supplemental Investment Program is embodied in Supplemental Budget No. 01 for CY 2021 of the municipality which was approved and enacted by the Sangguniang Bayan of Calasiao on May 17, 2021 through Appropriation Ordinance No. 04, S-2021;


