DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2020 OF STA. MARIA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P1,050,808.96 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Supplemental No. 1 Budget for Calendar Year 2020 involving total appropriations of **P1,050,808.96** which was approved on June 2, 2020 through Appropriation Ordinance No. 20-01-A;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget and the same showed substantial compliance with the provisions of the said Code and implementing circulars and other pertinent issuances;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the same in order considering that it complied with the requirements both in form and substance;
