PROVINCIAL RESOLUTION NO. 615-2019

URGING ALL LOCAL GOVERNMENT UNITS OF PANGASINAN TO IMPLEMENT A SUSTAINABLE ADVOCACY AND MANAGEMENT PROGRAM TO ADDRESS DENGUE INCIDENCE IN THEIR RESPECTIVE LOCALITIES

WHEREAS, dengue is one of the public health problems not only in the Province of Pangasinan but in all regions of the country;

WHEREAS, municipalities and cities are always in the forefront of the overall government thrusts and programs of the Province especially in the delivery of basic health needs of the people;

WHEREAS, the Provincial Health Office has reported out that a total number of 7,942 dengue cases with 11 fatalities were registered in the Province of Pangasinan for the period January 1 to October 28 for this year;

WHEREAS, a recent report also showed that the incidence rate of dengue in the Province is highest among age group between 5 to 14, with more males affected;

WHEREAS, local government units should initiate measures to prevent and reduce the spread of dengue in their respective localities which include among others the raising of awareness about its signs and symptoms, provisions of help or free treatment to affected people and dengue patients, identification and fumigation of highly affected areas, elimination of breeding places of dengue mosquitoes;

WHEREAS, full coordination of local government units together with the participation of the community is an effective way of reducing the dengue health impacts on people;



WHEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


