**RESOLUTION NO. 615-2020**

**APPROVING RESOLUTION NO. 160, S-2020 OF THE SANGGUNIANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED "AUTHORIZING THE UTILIZATION OF THE QUICK RESPONSE FUND (QRF) OF THE 30% OF THE MDRRM FUND OF THE LOCAL GOVERNMENT OF UMINGAN AMOUNTING TO THREE MILLION FIVE HUNDRED THIRTEEN THOUSAND NINE HUNDRED FIVE PESOS AND 40/100 (P3,513,905.40) TO BE UTILIZED FOR THE PURCHASE OF RELIEF GOODS FOR AFFECTED HOUSEHOLDS IN THE MUNICIPALITY OF UMINGAN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Umingan, Pangasinan submitted its Resolution No. 160, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Disaster Risk Reduction and Management Council of Umingan, Pangasinan in its Resolution No. 2, S-2020 dated March 17, 2020, has endorsed to the Sangguniang Bayan for approval the purchase of relief goods for COVID 19 affected households in the municipality which will be funded from the QRF 2020;

**WHEREAS**, on March 30, 2020, the Sangguniang Bayan approved the utilization of the 30% Quick Response Fund CY 2020 for the purchase of relief goods for COVID 19 affected households in the municipality. This is in consistent with Local Budget Circular No. 124 dated March 26, 2020 and NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013;
