APPROVING RESOLUTION NO. 40, S-2020 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED “APPROVING THE SECOND SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF INFANTA, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Resolution No. 40, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Infanta, Pangasinan has identified items in the municipality’s Supplemental Investment Program for CY 2020 with a total investment requirement of P2,253,834.82. This was endorsed to the Sangguniang Bayan for approval on March 6, 2020 thru MDC Resolution No. 2, S-2020 and was favorably acted upon by the Sangguniang Bayan on March 16, 2020 thru SB Resolution No. 40, S-2020;

WHEREAS, the Supplemental Investment Program of the municipality covers the fund augmentation for the personal services, maintenance and other operating expenses and capital outlay for the Infanta Waterworks System;

WHEREAS, funding for the full implementation of the Supplemental Investment Program is embodied in the Supplemental Budget No. 02 CY 2020 which was approved by the Sangguniang Bayan on March 16, 2020 thru Appropriation Ordinance No. 02, S-2020;
