## RESOLUTION NO. 618-2021

DECLARING ORDINANCE NO. 7, S-2020 OF THE SANGGUNIANG BAYAN OF UMINGAN, PANGASINAN, ENTITLED "AN ORDINANCE RECLASSIFYING THE LOT INTENDED FOR BALAI FARMERS HOUSING PROGRAM FUNDED BY THE DEPARTMENT OF AGRARIAN REFORM (DAR), SITUATED IN BARANGAY CARAYUNGAN SUR, UMINGAN, PANGASINAN FROM AGRICULTURAL TO RESIDENTIAL LAND" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Umingan, Pangasinan submitted its Municipal Ordinance No. 7, S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator, Provincial Agrarian Reform Program Officer II, and Regional Officer of the Ministry of Human Settlements and Urban Development have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 20 and 447 (a) (2) (viii) of R.A. No. 7160;

**WHEREAS**, the Municipality of Umingan, Pangasinan has an existing Zoning Ordinance implementing its Comprehensive Land Use Plan CY 2003-2012. Said ZO and CLUP should be updated to consider all reclassification of lands;

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 7, S-2020 of the Sangguniang Bayan of Umingan, Pangasinan, entitled "An Ordinance Reclassifying the Lot Intended for Balai Farmers Housing Program Funded by the Department of Agrarian Reform (DAR), Situated in Barangay Carayungan Sur, Umingan, Pangasinan from Agricultural to Residential Land" as within the conferred powers of the Sangguniang Bayan to enact;
