APPROVING RESOLUTION NO. 139-S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 2 FOR CY 2020 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF TEN MILLION SEVEN HUNDRED EIGHTY ONE THOUSAND THREE HUNDRED NINETY SEVEN PESOS AND NINETY TWO CENTAVOS (P10,781,397.92) FROM UNPROGRAMMED INTERNAL REVENUE ALLOTMENT (IRA) AND OTHER LOCAL SOURCES”

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 139-S-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council-Executive Committee of San Fabian, Pangasinan prepared the municipality’s Supplemental Annual Investment Program No. 2 for CY 2020. This was endorsed by the Council thru MDC Resolution No. 02, S-2020 dated April 21, 2020 to the Sangguniang Bayan for approval. This was approved by the Sangguniang Bayan on April 22, 2020 thru Resolution No. 139, S-2020;

WHEREAS, the Supplemental Annual Investment Program No. 02 of the municipality with a total investment requirement of P10,781,397.00 covers the granting of the First Tranche of the Modified Salary Schedule for Local Government Personnel and Special Risk Allowance to Frontline Public Health Workers during the COVID-19 outbreak, implementation of COVID-19 related programs/projects/activities, LDRRM PPAs, GAD PPAs, and other development projects of the LGU;

WHEREAS, funding for the implementation of most of the PPAs in the amount of P9,731,397.92 is embodied in the Supplemental Budget No. 02, CY 2020 which was approved by the Sangguniang Bayan on April 22, 2020 thru Appropriation Ordinance No. 02, S-2020;

WHEREAS, the remaining amount of P1,050,000.00 will be derived from the realignment of the projects from the LGU's Development Fund, from *various small scale development projects* to *"COVID-19 related initiatives"*;

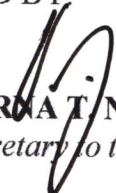
