PROVINCIAL RESOLUTION NO. 622-2021

AMENDING BY SUBSTITUTION THE WORD POULTRY TO PIGGERY IN PROVINCIAL RESOLUTION NO. 567-2021, ENTITLED: "DIRECTING THE COMMITTEE ON ENVIRONMENT, NATURAL RESOURCES AND ENERGY TO LOOK INTO THE ALLEGED OPERATION OF POULTRY IN MANGATAREM, PANGASINAN PARTICULARLY AT BARANGAY UMANGAN, IN AID OF LEGISLATION"

WHEREAS, Section 17 of RA 7160 provides that the Sangguniang Panlalawigan shall ensure the efficient and effective delivery of basic services and facilities in the province, and in addition it shall adopt measures and safeguards against pollution and for the preservation of the natural ecosystem in consonance with approved standards on environmental sanitation;

WHEREAS, the Sangguniang Panlalawigan is in receipt of reports that a piggery farm in Barangay Umangan has allegedly failed to control the foul odor emanating from its operations causing environmental hazards to the area and its nearby barangay;

WHEREAS, the barangay officials of the affected areas have requested the Sangguniang Panlalawigan to look into the alleged operation of the piggery farm considering that some provisions of the compromise agreement that settled the matter have been violated;

WHEREAS, the Sangguniang Panlalawigan as the highest legislative body of the Province is empowered to conduct an inquiry/committee hearing on certain matters that are of public interest and in aid of legislation;

WHEREAS, the Committee on Environment, Natural Resources and Energy is the proper Body to conduct the said inquiry/committee hearing as the matter of regulation on the impact of piggery operations to the environment is within its specific area of legislation to address;

NOW THEREFORE, on motion of SP Member Von Mark R. Mendoza, duly seconded, it was -


