APPROVING RESOLUTION NO. 30, S-2020 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED “APPROVING THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPAL SUPPLEMENTAL BUDGET NO. 3, S-2020 FROM BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) OF THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN TO ENHANCE SUPPORTS AGAINST COVID-19”

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Resolution No. 30, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of San Quintin, Pangasinan has identified programs/projects/activities to address emergency response measures to COVID-19 pandemic. This is embodied in the municipality’s Supplemental Annual Investment Program which was endorsed thru MDC Execom Resolution No. 3, S-2020 dated April 15, 2020 to the Sangguniang Bayan for approval. This was approved by the Sangguniang Bayan on April 21, 2020 thru Resolution No. 30, S-2020;

WHEREAS, the Supplemental Annual Investment Program of the municipality has an investment requirement of P9,929,328.00 which will be funded from Bayanihan Grant to Cities and Municipalities (BGCM) under RA 11469 (The Bayanihan to Heal as One Act);
