**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AN EXPLORATORY TALK WITH GLOBAL TRADE VENTURE CO., LTD. FOR THE PROPOSED ESTABLISHMENT OF THE PANGASINAN FISH FARMING PROJECT (PFF-PROJECT) IN THE PROVINCE**


