APPROVING RESOLUTION NO. 303, S-2019 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE MUNICIPALITY OF BAYAMBANG FOR CALENDAR YEAR 2020"

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Resolution No. 303, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Municipal Development Council of Bayambang, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2020. This was endorsed by the Council to the Sangguniang Bayan thru MDC Resolution No. 08-002, S-2019, dated August 16, 2019 and was favorably acted upon by the Sangguniang Bayan on September 16, 2019 thru SB Resolution No. 303, S-2019;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of

Bayambang, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities, d) Activities in pursuance of the objectives of GAD of the LGU. Also attached to the AIP, among others, are the following: a) DILG-endorsed GAD Plan and Budget, b) Municipal Disaster Risk Reduction and Management Investment Plan, c) Local Climate Change Action Plan, d) Peace and Order Plan, e) List of Programs/Projects/Activities (PPAs) for the Local Council for the Protection of Children, f) List of PPAs for Senior Citizens and Persons with Disabilities, g) List of PPAs for HIV, h) List of PPAs to address illegal drugs, i) Nutrition Action Plan, j) Culture Development Plan, and k) Indicative Annual Procurement Plan of the LGU;

WHEREAS, the AIP of Bayambang for CY 2020 has a total investment requirement of P2,074,602,240.00. Of this, P556,732,826.60 will be financed by the LGU as embodied in their 2020 Annual Budget passed and approved by the Sangguniang Bayan through Appropriation Ordinance No. 01, S-2019 (General Fund/P511,951,287.20) and Appropriation Ordinance No. 02, S-2019 (Special Economic Enterprise/P44,781,539.40), S-2019 dated September 16, 2019. The remaining amount, estimated at P1,517,869,413.40 will be derived from external sources;

WHEREAS, said AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P281,000,000.00) amounting to P56,200,000.00 is allocated for development projects. The development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs and projects included in the Municipal Disaster Risk Reduction and Management Investment Plan amounting to P21,400,000.00 are in accordance to Section 21 of RA 10121 and Memorandum Circular No. 2013-1 of the NDRMMC, DBM & DILG dated March 25, 2013 (Joint Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). **However, the DRRM Plan shall still be submitted by the municipality to the Office of Civil Defense (OCD) for review as per Local Budget Memorandum No. 77 dated May 15, 2018;**

WHEREAS, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Plan and Budget of Bayambang was reviewed by the Department of Interior and Local Government (DILG) Provincial Office, and found to be compliant in form and in contents with the provisions of the Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";

WHEREAS, the AIP also included projects for funding from external sources, such as NGAs;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 303, S-2019 of the Sangguniang Bayan of **Bayambang**, Pangasinan, entitled "Approving the Annual Investment Program (AIP) of the Municipality of Bayambang for Calendar Year 2020";
