PROVINCIAL RESOLUTION NO. 629-2021

**AUTHORIZING THE UTILIZATION OF THE TRUST FUND-
DEPARTMENT OF ENERGY FOR THE PROCUREMENT OF
MOTOR VEHICLES**

WHEREAS, Supplemental Investment Program No. 2 of the Province of Pangasinan for Calendar Year 2021 approved on March 22, 2021 embodied, among others, various projects which shall be funded from the share of the Province from the Energy Regulation (ER) 1-94 of the 1000MW and 200MW Sual Coal-Fired Thermal Power Plant and the San Roque Power Plant;

WHEREAS, Provincial Resolution No. 430-2021, approved by the Sangguniang Panlalawigan on May 10, 2021, authorized the Provincial Governor to purchase two (2) units of motor vehicle for use by the Provincial Government of Pangasinan;

WHEREAS, there is a need to utilize a portion of the trust fund's share from the Department of Energy amounting to P5,930,076.00 for the procurement of two (2) units of motor vehicle to be used in accordance with specific allowable utilization guidelines of the trust fund;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as it is hereby authorized, the utilization of the Trust Fund-Department of Energy for the procurement of motor vehicles;






