WHEREAS, LANDBANK weAccess is an internet banking facility developed for the bank's institutional clients, both private corporations and government entities, which allows them to make selected banking transactions online;

WHEREAS, LANDBANK Link.BizPortal is an electronic payment (e-Payment) facility that allows clients to pay for products and services through the internet from both the government and private institutions;

WHEREAS, the Provincial Government of Pangasinan recognizes the necessity of enrolling in the online services, and electronic and collection system of the Land Bank as it is in line with the objectives of enhancing treasury operations and intensifying revenue generation;

WHEREFORE, in view of the foregoing, on motion of SP Member Angel M. Baniqued, Jr., duly seconded, it was –


