**APPROVING RESOLUTION NO. 141-092419 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED "APPROVING THE FIRST SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF POZORRUBIO FOR CY 2019 FUNDED BY UNAPPROPRIATED SURPLUS AND SAVINGS FROM PREVIOUS YEAR OF POZORRUBIO, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 141-092419 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Pozorrubio Pangasinan has formulated the municipality's 1<sup>st</sup> Supplemental Investment Program for Calendar Year 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 01, S-2019 dated August 13, 2019. The Sangguniang Bayan approved the 1<sup>st</sup> Supplemental Investment Program on September 24, 2019 through Resolution No. 141-092419. This is in pursuance to Sections 106, 109 and 114 of RA 7160;


