RESOLUTION NO. 639-2020

DECLARING MUNICIPAL ORDINANCE NO. 2019-04 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING ANY PERSON OR PERSONS FROM SNEAKING OR BRINGING IN ANY CONTRABANDS AND OTHER BANNED ITEMS INSIDE THE BALUNGAO DISTRICT JAIL AND BALUNGAO MPS DETENTION FACILITY AND FURTHER IMPOSING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Municipal Ordinance No. 2019-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 16 and 447 (a) (1) (ii), (iii) and (v) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the requirements of posting and publication pursuant to Section 59 and 511 of RA 7160;
