RESOLUTION NO. 64-2020

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2019 OF LABRADOR, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P2,180,000.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Labrador, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2019 involving total appropriations of **P2,180,000.00** which was approved on December 16, 2019 through Appropriation Ordinance No. 4-2019;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations; *and*
2. The grant of Collective Negotiation Agreement (CNA) Incentive for FY 2019 to municipal officials and employees shall be subject to the provisions of Budget Circular No. 2019-5 of the Department of Budget and Management dated November 7, 2019.
