URGING THE MANAGEMENT INFORMATION SERVICES OFFICE (MISO) TO CONDUCT A FEASIBILITY STUDY FOR THE POSSIBLE ESTABLISHMENT/CREATION OF A PROVINCIAL TECHNICAL AND REGULATORY TEAM TO OVERSEE THE SOCIAL MEDIA PAGES OF THE DIFFERENT OFFICES OF THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, the Provincial Tourism and Cultural Affairs Office (PTCAO) will be launching a project called Pangasinan Tourism Branding, Website and Social Media Marketing through a private project service provider;

WHEREAS, other offices might follow the same and create their own social media accounts over and above the existing provincial website of Pangasinan;

WHEREAS, in order to avoid complication in the future and to have a uniformity of the stand and releases of the Province, there is a need to conduct a feasibility study for the possible establishment/creation of a technical and regulatory team to oversee and control all the websites and social media pages of the provincial government offices;

WHEREAS, the Management Information Services Office (MISO) is responsible for planning, developing and implementing hardware and software applications, programming and systems network and integration of a management information system in the Province;

WHEREAS, the Sangguniang Panlalawigan shall seek the assistance of the MISO in the conduct of the said feasibility study;

WHEREAS, part of the study to be undertaken by MISO is the inventory of the existing websites/social media pages of the provincial government offices of Pangasinan;
