RESOLUTION NO. 640-2019

DECLARING MUNICIPAL ORDINANCE NO. 4-2019 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR THE ESTABLISHMENT OF SMOKE-FREE ENVIRONMENTS IN PUBLIC AND ENCLOSED PLACES IN ANDA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Municipal Ordinance No. 4-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 447 (a) (1) (viii), (3) (ii) of RA 7160; Executive Order No. 26 entitled "Providing for Establishment of Smoke-Free Environments in Public and Enclosed Places; RA No. 8749, otherwise known as the Philippine Clean Air Act of 1999; and RA No. 9211 or the Tobacco Regulation Act of 9211;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the posting and publication requirements of Section 59 (c) and 511 (a) of RA 7160;
