APPROVING RESOLUTION NO. 25, S-2020 OF THE SANGGUNIANG BAYAN OF SAN QUINTIN, PANGASINAN, ENTITLED "APPROVING THE PROGRAMS, PROJECTS AND ACTIVITIES OF THE REVISED ANNUAL INVESTMENT PLAN (AIP) OF THE MUNICIPALITY OF SAN QUINTIN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Resolution No. 25, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Disaster Risk Reduction and Management Council in its Resolution No. 1, S-2020 dated March 30, 2020, has recommended supplementary/new programs/projects to be funded by the QRF from year 2015-2019 to be incorporated in the Annual Investment Program for CY 2020. This was approved by the Sangguniang Bayan through Resolution No. 27-A, S-2020 dated April 3, 2020;

WHEREAS, the Local Development Council has revised the CY 2020 Annual Investment Program to include LDRRM programs/projects in response to COVID 19 pandemic which will be funded from the Special Trust Fund/Savings Reserves of the Quick Response Fund from the year 2015-2019 amounting to P14,850,000.00. This was endorsed to the Sangguniang Bayan for approval through MDC Executive Committee Resolution No. 2-A, S-2020-01 dated March 30, 2020;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
