PROVINCIAL RESOLUTION NO. 643-2021

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN MEMORANDA OF AGREEMENT (MOA) WITH BIOCHEM SCIENTIFIC DIAGNOSTIC SUPPLY FOR THE PROVISION OF HOSPITAL EQUIPMENT UNDER PUBLIC-PRIVATE PARTNERING SCHEME FOR THE EASTERN PANGASINAN DISTRICT HOSPITAL AND URDANETA DISTRICT HOSPITAL

WHEREAS, the Provincial Government of Pangasinan has been gradually embarking on new programs and projects to greatly enhance the delivery of public health and medical services to the people;

WHEREAS, the Provincial Government of Pangasinan, through the Eastern Pangasinan District Hospital (EPDH) and Urdaneta District Hospital (UDH), has been offered by the Biochem Scientific Diagnostic Supply (Biochem) of bacteriology identification machine called Vitek 2 Fully Automated Bacteriology Analyzer;

WHEREAS, the much-needed equipment/machine could add on to better and accessible ways of serving the people of Pangasinan especially the underprivileged;

WHEREAS, the EPDH and UDH have agreed in turn, to purchase from Biochem the consumable reagents needed in the operation of the machine and medical supplies for the hospital;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan, represented by Honorable Governor Amado I. Espino III, to enter into Memoranda of Agreement with Biochem Scientific Diagnostic Supply, represented by Ms. Maricris A. Valdeo, Administrative Manager;




