**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 OF THE PROVINCE OF PANGASINAN FOR CALENDAR YEAR 2020 FOR THE REALIGNMENT OF PORTION OF ALLOTMENT FOR THE “PURCHASE OF GROCERIES/FOOD ITEMS” TO AUGMENT THE FUND FOR THE “COVID-19 SPECIAL RISK ALLOWANCE FOR PUBLIC HEALTH WORKERS”**

**WHEREAS**, presented for consideration is the Supplemental Investment Program No. 5 of the Province of Pangasinan as endorsed by the Provincial Development Council Resolution No. 02, Series of 2020;

**WHEREAS**, pursuant to the Local Government Code of 1991, the Provincial Development Council is mandated to prepare and formulate medium and long-term plans in harmony with the programs, projects and activities of the Province;

**WHEREAS**, the “Purchase of Groceries/Food Items” and “COVID-19 Special Risk Allowance for Public Health Workers” were both embodied in the Supplemental Investment Program No. 2 of the Province of Pangasinan, to be funded from Energy Regulation (ER) 1-94 Reforestation, Watershed Management, Health and/or Environment Enhancement Fund (RWMHEEF) converted to Electrification Fund, endorsed by the PDC Executive Committee thru Resolution No. 04-20 and approved by the Sangguniang Panlalawigan thru Provincial Resolution No. 349-2020;

**WHEREAS**, there is a need to realign a portion of the allotment from the “Purchase of Groceries/Food Items” to augment the allotment for the “COVID-19 Special Risk Allowance for Public Health Workers” in the amount of P4,685,000.00;

**WHEREAS**, the realignment of a portion of the allotment to augment the identified project is geared toward the promotion of the welfare of public health workers during this time of COVID-19 pandemic;
