RESOLUTION NO. 646-2020

DECLARING MUNICIPAL ORDINANCE NO. 01, S-2020 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF SANITARY INSPECTOR II, SG-8, AND SUPPLY OFFICER I, SG-10" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Municipal Ordinance No. 01, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 76 and 447 (a) (1) (viii) of RA 7160;

WHEREAS, however, the position title of Supply Officer I, Salary Grade 10, should be changed to Administrative Officer I, to conform with the provisions of Budget Circular No. 2004-3 dated March 6, 2004 entitled "Conversion of Positions Performing Staff/Non-Technical Functions" and the position title of Administrative Assistant II as reflected in the plantilla of personnel should be retained as Sanitation Inspector as the duties and responsibilities enumerated in Section 2(a) 2 of the subject ordinance is that of a sanitation inspector;

WHEREFORE, in view of the foregoing, on motion of SP Members Donabel N. Fontelera and Margielou Orange D. Humilde-Verzosa and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –


