WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its SB Resolution No. 2021-32 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the subject resolution is in consonance to Sections 106, 109 and 114 of R.A. No. 7160;

WHEREAS, the Local Development Council of Binmaley, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2021 which was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 2, S-2021 dated June 17, 2021;

WHEREAS, said Supplemental AIP with a total investment requirement of P11,118,944.83 covers the fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal offices, and implementation of development programs/projects of the municipality;
